

**ICE SKATING, HOCKEY, AND OTHER ACTIVITY
RELEASE OF LIABILITY, WAIVER OF CLAIMS, & ASSUMPTION OF RISK**

BY SIGNING THIS DOCUMENT YOU ARE WAIVING CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE.

ASSUMPTION OF RISK: I am aware that ice skating and other recreational activities including but not limited to, hockey, broomball, recreational skating and figure skating, indoor football, soccer, lacrosse and floor hockey and activities associated with traveling for such activities (the "Activities") at any Dr Pepper StarCenter, PSA StarCenter, Valley Ranch StarCenter, and other locations (collectively, the "Arena") involve certain inherent risks, dangers and hazards, which can result in serious personal injury or death and other personal and property damages. As such, I hereby freely agree to assume and accept any and all known and unknown risks of the injury or damages arising from my participation in the Activities. I further recognize and acknowledge that the risks inherent in the Activities can be greatly reduced by: taking lessons, abiding by the Skater Responsibility Code (now known as "Your Responsibility Code") and using common sense.

RELEASE AND WAIVER OF CLAIMS AGREEMENT: In consideration for allowing me to participate in the Activities, I hereby agree as follows:

1. TO WAIVE ANY AND ALL CLAIMS that I have or may in the future have against the Arena; Hicks, Inc.; Hicks Sports Group Holdings, LLC; Hicks Sports Group, LLC; HSG Partnership Holdings LLC; Dallas Stars, L.P; VRH Partners.; Crull Fitness LLC; Plano Sports Authority; the Cities of Frisco, Eules, Farmers Branch, Plano, Irving, McKinney & Duncanville; any hockey or other league bodies, and any of their related entities (the "Released Parties") resulting from the my Activities at the Arena or at any other location, including, but not limited to, other arenas and at various locations when traveling relating to the Activities.
2. TO RELEASE THE RELEASED PARTES FROM ANY AND ALL LIABILITY FOR ANY LOSS, DAMAGE, INJURY OR EXPENSE THAT I MAY SUFFER, OR THAT MY NEXT OF KIN MAY SUFFER, AS A RESULT OF MY PARTICIPATION IN THE ACTIVITIES, DUE TO ANY CAUSE WHATSOEVER, INCLUDING NEGLIGENCE OR BREACH OF CONTRACT ON THE PART OF THE RELEASED PARTIES IN THE OPERATION, SUPERVISION, DESIGN, OR MAINTENANCE OF THE ARENA OR RELATING TO MY PARTICIPATION IN THE ACTIVITIES;
3. ARBITRATION: In further consideration of allowing me to participate in the Activities, I hereby agree to submit to binding arbitration any and all claims which I believe I may have against the Released Parties arising from the Activities. The arbitration shall be pursuant to the rules of the American Arbitration Association. The arbitration shall apply the Federal Rules of Evidence to all proceedings. Arbitration shall be commenced within one (1) year from the date on which any alleged claim first arose. Further, the arbitration shall be held in Dallas, Texas, unless the parties mutually agree otherwise. The submission to the American Arbitration Association shall be unlimited and any court of competent jurisdiction may enforce the arbitration award.
4. I consent to the placement of my name/photo (and/or the name/photo of my minor child(ren)) on the Released Parties' websites. I waive all potential claims and liabilities against the Released Parties, relating in any way to the collection, use and disclosure of any of personally identifiable information on the internet, including compliance with the Federal Trade Commission's Children's Online Privacy Protection Act (COPPA) or any other law or regulation, if applicable.

BINDING EFFECT OF AGREEMENT: In the event of my death or incapacity, this Agreement shall be effective and binding upon my heirs, next of kin, executors, administrators, assigns and representatives.

ENTIRE AGREEMENT: In entering into this Agreement, I am not relying upon any oral or written representations other than what is set forth in this Agreement.

I HAVE READ AND UNDERSTAND THIS AGREEMENT AND I AM AWARE THAT BY SIGNING THIS AGREEMENT I AM WAIVING CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE THE RELEASED PARTIES, THE ARENA AND THE RELATED LEAGUES.
